**STEPHEN P. HARBECK** 

President and Chief Executive Officer, Securities Investor Protection Corporation

Recipient of the: LEADERSHIP ACHIEVEMENT AWARD

Mr. Harbeck joined SIPC in 1975, serving as a trial and appellate attorney, General Counsel of SIPC from 1995 through 2003, and was elected as SIPC's President and Chief Executive Officer in December, 2003. Mr. Harbeck's tenure as President is marked by liquidations of Lehman Brothers, the largest bankruptcy of any kind in history, Bernard L. Madoff Investment Securities, the largest Ponzi Scheme in history, and MF Global, the eighth largest bankruptcy in history.

Mr. Harbeck served as a Sergeant with the Reconnaissance Platoon, First Battalion, Seventh Cavalry, of the First Cavalry Division, Airmobile, in the Republic of South Vietnam, from August 1970 through May 1971.



KEVYN D. ORR Partner, Jones Day

Recipient of the: CITY of DETROIT RESTRUCTURING LEADERSHIP ACHIEVEMENT AWARD

Mr. Orr has practiced law in the areas of business restructuring, financial institution regulation, and commercial litigation for three decades.

Mr. Orr was appointed as the Emergency Manager for the City of Detroit by Michigan Governor Richard D. Snyder, serving from March 2013 through December 2014. Under Mr. Orr's leadership, the city successfully restructured \$18 billion in debt, reduced overall debt by \$7 billion, developed and implemented a multiyear \$1.7 billion revitalization plan for city services and operations.

Prior to re-joining Jones Day in May 2015, Mr. Orr served as Special Counsel for the Emergency Manager for Atlantic City, appointed by New Jersey Governor, Christ Christie (January 2015 through April 2015).
